City Attorney/David Strickland

Strickland brought up discussion regarding the resolution and ordinance to change the speed limit on East Richardson. The draft from Robert & Company that was approved in December 2011, did not match what was approved by DOT's survey of streets in April 30, 2012. Strickland suggested the ordinance should match what was approved with DOT since their document defines what streets you can and cannot run radar on.

Cemetery/Public Safety**

Pace: Informed all that Chief Harvey has sent the advertisement for the additional Police Office and applications will be accepted until July 13, 2012.

Pace delivered the second reading and a motion to increase the speed limit on East Richardson Street to 30 MPH. The motion was seconded by Windham. The council vote was unanimous with council David Eady not in attendance. Motion Withdrawn due to following discussion.

Strickland, the changes I suggested previously based on the documents that went to DOT. The substance doesn't differ a lot but the way the grid was done that was sent back to DOT is different enough that I could envision attorneys coming into court and arguing speed limits and such as that in the Municipal court. Unless you have a deadline I would request you consider tonight as a first reading and next month the second reading and passage just because it changed enough that it could cause problems.

Windham, I don't understand we had a first reading already. Strickland, what was handled in the first reading wasn't what was in the DOT response sent in April regarding the grid showing the On System and Off System Road Ways. They go out and calculate mileage and what they are showing on their grid is not what we have in our ordinance.

It's the same streets but for example where they might say mile marker 13.40 to mile marker whatever. There were errors in those documents. So what you have here is verbatim what DOT sent and what was signed off and approved in the list of road ways. I would suggest you have this as a first reading and then the second reading at your next meeting. It's the same road ways; there were just some errors in the grid.

Holt, so what you are saying is there is enough change from our first reading to now that we should have a first reading again.

Strickland, that right, I'm not suggesting you change road ways. I'm saying there were errors in the various descriptions of the way the road way were calculated.

Pace, I will withdraw the motion and change this to be the first reading of an ordinance to increase the speed limit on East Richardson. The motion was seconded by Windham. The council vote was unanimous with Councilman Terry Smith Eady not in attendance.

James H. Windham
Buildings & Grounds/Parks/Trees

Windham, we sent RFP's on the Old City Hall. We have the proposals back. We had three people drop out and the other two bids are dramatically over our budget. We have entered discussion with the low bidder. He is going to bring back cost on various items. The building committee plans to meet with the bidder and college and see if we can provide the college with what they would like and what we can afford and what they might want to chip in and help with.

Davis, what is the status of the sewer connection to the building?

Miller, that should begin next week, based on the survey of where the utilities are we are going to have to add one additional manhole to get it on city owned property and avoid the tree on the corner. We are waiting to get the cost back on the change.
