#### **Mayor's Reports**

Mayor announced he will be at the Board of Commissioners meeting tomorrow night October 7, to lead the pledge.

### **Sanitary Sewer Connections -**

Bob Schwartz, City Manager - The city code requires any house located within 100 feet of a sewer line connect to the sanitary sewer. We have eighteen owner occupied homes in our city that meet this requirement and are not connected. The standard tap fee is \$3,600. We recommend a motion to approve the special tap fee of \$1,700 along with a payment plan option. Attachment E & F

## Maintenance Facility Generator -

Bob Schwartz, City Manager presented two quotes for a generator to be installed at the Maintenance Facility with a recommendation that city council award a purchase order to Ozburn Electrical Contractors as the low bid for a generator and installation at the maintenance facility in the amount of \$10,256.00. This is in the FY2015 capital projects budget for \$20,000. Attachment G

## City Entrance Signs -

Mayor Jerry Roseberry announced he is working with a company in Peachtree City on a design for the city entrance signs and presented several samples. The material is polyethylene that is hard like brick and won't weather, rot or peal. An estimated cost would be around \$5,000 each. We won't know the exact cost until we have selected the design and material. Mayor Roseberry stressed the deadline in getting this completed before the Convocation in December. It was suggested there be a committee to go look at the signs and materials before making a decision and asked for volunteers. Councilmember Jim Windham volunteered and asked David Eady if he would be available to go with him and City Manager Bob Schwartz. Mayor Roseberry appointed Jim Windham, David Eady and Bob Schwartz to serve on this committee.
