Re: Alarm/Security System Recommendation

On September 8, 2021, I emailed Nichols Security, AllStar Alarms and Sound, and Viper Security Technologies to request an updated/confirmed quote, references, and an assurance the company was not contemplating a sale or transfer. To date, I have only heard back from Viper.

I do not believe it is advisable to contact Nichols and AllStar a second time as they are supposed to be in the business of responsiveness and so their silence indicates poor service and/or a lack of interest in this bid request.

The new Viper Quote has dropped from \$299.98/month to \$239.40/month due to our multiple location request, which should have been reflected in the original quote. Viper has stated they are not contemplating a sale or transfer of the company. I did speak with Viper directly in order to confirm the quote and I found their service to be prompt and courteous.

There were three references sent from Viper: D&D Garage (Covington), Three Ring Studies (Covington) and Beckham's Used Cars (Milledgeville). D&D indicated years of good service. They have never had a break-in but have set off the alarm and always are met with the appropriate level of prompt service. Beckham's said using Viper has been a great experience and that their service was spot-on both for the alarm and phone service. I left a voicemail for Three Ring and have not heard back.

My recommendation is for Viper Security Technologies.
